2 Upon commencing at 8:28 a.m.

4 **SERGEANT GIRARD:** The date is  
5 March 11th, 2005, the time is 8:28 a.m. And we  
6 are in interview room number one of the  
7 Professional Standards Unit Offices on the 10th  
8 floor of the Confederation Building, at 457 Main  
9 Street in Winnipeg. My name is Detective Sergeant  
10 Roger Girard and also present is Sergeant Con  
11 Pearson.

12 For the purpose of voice recognition,  
13 Con, can you identify yourself by name?

14 **SERGEANT PEARSON:** Con Pearson.

15 **SERGEANT GIRARD:** We are both members  
16 of the Professional Standards Unit. This is an  
17 interview with Constable Shaun Veldman regarding  
18 Professional Standards Unit file number 05-017.  
19 For the purpose of voice recognition, Shaun, can  
20 you please identify yourself by full name and  
21 badge number?

22 **CONSTABLE VELDMAN:** My full name is  
23 Shaun William Veldman, my badge number is 1995.

24 **SERGEANT GIRARD:** Okay. I will remind  
25 you that in accordance with service policy, our

1 conversation is being recorded, and for that  
2 purpose today we are using an Olympus DS4000  
3 digital voice recorder.

4 You were contacted and requested to  
5 attend for an interview, and I don't remember, I  
6 don't think -- did we have this date set or I  
7 think we were talking sort of back and forth on  
8 the phone --

9 **CONSTABLE VELDMAN:** Yeah, originally  
10 the date did change several times due to my annual  
11 leave.

12 **SERGEANT GIRARD:** Right.

13 **CONSTABLE VELDMAN:** So we had it  
14 pre-arranged for today.

15 **SERGEANT GIRARD:** Yeah. And then you  
16 called me this morning and said you would like to  
17 come in earlier because you had court?

18 **CONSTABLE VELDMAN:** That's right.

19 **SERGEANT GIRARD:** Okay. You arrived  
20 at our office as short time ago, I met you  
21 downstairs.

22 **CONSTABLE VELDMAN:** That's right.

23 **SERGEANT GIRARD:** We came up to this  
24 room. I give you the preamble and gave you a  
25 little bit of the background as to why we are

1 involved in this matter and what we are going to  
2 be speaking with you about today. And then you  
3 had no questions so I started the recorder.

4 So is that an accurate account of what  
5 has taken place prior to me turning the recorder  
6 on?

7 **CONSTABLE VELDMAN:** Yes, it is.

8 **SERGEANT GIRARD:** It is our practice  
9 to ensure that members understand their status  
10 when being interviewed, and I remind you that you  
11 are being interviewed as a witness in this matter.  
12 This statement may be used in any criminal, civil  
13 or service proceeding, or it may not be used in  
14 any proceeding at all.

15 Were any threats made to you or were  
16 any promises or hopes of reward offered to you in  
17 relation to providing a statement?

18 **CONSTABLE VELDMAN:** No.

19 **SERGEANT GIRARD:** Was anything said to  
20 you by anyone that would influence what you might  
21 say to us in this statement?

22 **CONSTABLE VELDMAN:** No.

23 **SERGEANT GIRARD:** Okay. So like I  
24 explained before we started the recorder, this is  
25 a matter that we are looking into, assisting the

1 East St. Paul Police, regarding the incident  
2 involving Constable Harvey-Zenk on the early  
3 morning hours of February 25th, roughly 7:00 a.m.

4 And it is our understanding that there was a  
5 gathering at Branigan's earlier, I guess the  
6 previous evening, and another one at Constable  
7 Sean Black's. So if you could just advise us  
8 what, if any, involvement you had with that?

9 **CONSTABLE VELDMAN:** The evening of the  
10 24th, I was working evening shift, which would  
11 have ended at 2:30 in the morning. And our shift  
12 had gotten together and arranged to go to  
13 Branigan's after work, if we could get off early.  
14 There was a sign up sheet to get EDL and my  
15 partner and I were at the bottom of that list. So  
16 we, I believe, got off work at about 12:30. We  
17 took EDL for the remainder of the shift at 12:30,  
18 myself and Dan Mikawoz that I was working with. I  
19 then went straight from work to Branigan's where  
20 the entire shift was there already, including  
21 Derek. I was present at Branigan's for about two  
22 hours, I guess, until about just after  
23 2:00 o'clock, and left Branigan's to go home as I  
24 had court immediately at 9:00 o'clock in the  
25 morning. So there had been some talk about going

1 to somebody's house afterwards, but I said I had  
2 court in the morning and basically left not  
3 knowing where people were going to go, or what had  
4 been decided at least. I wanted to get home and  
5 get to bed so --

6 **SERGEANT GIRARD:** Okay. So you went  
7 straight home after Branigan's?

8 **CONSTABLE VELDMAN:** Yes.

9 **SERGEANT GIRARD:** Okay. You said you  
10 were with Constable Mikawoz that night?

11 **CONSTABLE VELDMAN:** Yes.

12 **SERGEANT GIRARD:** You said you took  
13 EDL at 12:30.

14 **CONSTABLE VELDMAN:** Yeah, and I went  
15 straight there.

16 **SERGEANT GIRARD:** Straight there,  
17 okay.

18 **CONSTABLE VELDMAN:** So whatever time  
19 it was that I got there.

20 **SERGEANT GIRARD:** Who do you recall  
21 being at Branigan's when you arrived?

22 **CONSTABLE VELDMAN:** Like I said, I  
23 think just about our whole shift was there,  
24 including some people from downtown, I believe.  
25 So as far as names, it would have been Chris

1 Humniski, Jimmy Anderson, Jack Kapka, Ted  
2 Michalik, a lot of people there. There was --  
3 Norbert Bauer who was there. Tracy Fudge, I think  
4 came after I did. Tracy Fudge and Sammi Haddad  
5 arrived right about the same time that we did.  
6 Derek was there. Jay Nolet was there, myself, and  
7 Dan Mikawoz. TJ Spruyt, I believe his name is,  
8 was there, Dave Harding, Christian Guyot, Sean  
9 Black, Ken Azaransky. And I may be missing a  
10 couple of people but -- there was some guys from  
11 traffic I think were there, Werner Toews and  
12 Gordon Schneider. Off the top of my head that's  
13 it.

14 **SERGEANT GIRARD:** Predominantly your  
15 shift and then some people from division 11 which  
16 would have been B1?

17 **CONSTABLE VELDMAN:** Yes, I believe  
18 they are in B1.

19 **SERGEANT GIRARD:** Okay. Whereabouts  
20 in Branigan's was everyone sitting, as far as just  
21 what section of the restaurant?

22 **CONSTABLE VELDMAN:** I describe it as  
23 the southeast corner of the lounge, I guess, the  
24 very southeast corner. And when we came,  
25 everybody was pretty much there already, so

1 everyone had established their spot at the table,  
2 so we kind of had to pull up a couple of tables  
3 and chairs and sit on the outside of it, I guess.

4 **SERGEANT GIRARD:** So what was going  
5 on? Like how would you characterize the  
6 gathering?

7 **CONSTABLE VELDMAN:** Just typical, 13  
8 different conversations going on at the same time,  
9 typical social gathering I guess.

10 **SERGEANT GIRARD:** Okay. Now, I guess  
11 specifically relating to Derek Harvey-Zenk, where  
12 was he sitting in relation to you?

13 **CONSTABLE VELDMAN:** When I first got  
14 there, Derek was sitting in this large group,  
15 Derek was kind of sitting in the middle or further  
16 towards the back of the lounge. And then when we  
17 came, there was too many people to all fit in that  
18 corner, so we pulled up a table and sat on the  
19 outside of this group of people I guess. So he is  
20 sitting, I guess, like two tables away from me  
21 when I first got there.

22 **SERGEANT GIRARD:** Okay.

23 **CONSTABLE VELDMAN:** As people left,  
24 some people left early which opened up some spots  
25 further, closer in. So I ended up moving closer

1 to where Derek would have been sitting as people  
2 left, which would have been half an hour after I  
3 got there probably.

4 **SERGEANT GIRARD:** Okay. Do you know  
5 what Derek was drinking that night?

6 **CONSTABLE VELDMAN:** No, I don't.

7 **SERGEANT GIRARD:** Okay. What about  
8 any food?

9 **CONSTABLE VELDMAN:** I don't know if he  
10 had any food.

11 **SERGEANT GIRARD:** Okay. All right.  
12 Was anyone at this gathering obviously  
13 intoxicated?

14 **CONSTABLE VELDMAN:** Not that I  
15 noticed, no.

16 **SERGEANT GIRARD:** Okay. So pretty  
17 quiet gathering then. All right. Then you left  
18 at closing time? I can't remember what time you  
19 said?

20 **CONSTABLE VELDMAN:** Yeah, I don't know  
21 what time it was, but I do remember wanting to get  
22 out of there before 2:30, and it was somewhere  
23 between 2:00 and 2:30 that I left.

24 **SERGEANT GIRARD:** And you paid for  
25 your own food and beverages or whatever you had?

information that we haven't covered in this, anything that we have overlooked that you think might be important?

**CONSTABLE VELDMAN:** No, I don't.

**SERGEANT GIRARD:** Okay. Anything else

you want to say?

**CONSTABLE VELDMAN:** No.

**SERGEANT GIRARD:** Okay. The time is

8:38 a.m., this interview is concluded and the recorder is being turned off.
