I trust the following report responds to your inquiries.

An immediate review of the file notations reveal in the days leading up to the preliminary inquiry after receiving the offer of a plea of guilty to dangerous driving from the defence on July 12, 2007 I met on July 13, 2007 for 1 hour with Mr. Taman and his son wherein they were informed of the offer and the difficulties facing the prosecution and that it would be accepted by the Crown - in addition the sentence proposal and law was reviewed with them.

This meeting followed my meeting with Mr. Kaplan to advise Prosecutions of the call from Mr. Wolson.

The case was then to commence on Monday July 16, 2007 but did not and again at the courthouse after the adjournment to the following day I met with both the Sveinson and Taman families independently to brief them and remained with the parties at the courthouse for over 2 hours.

I say independently as the Sveinson family was the first family I met with in this matter.

After meeting with the Sveinsons I met with the Tamans, being unaware of the family dynamic. At that initial meeting I was reminded and told by the Tamans that they were the registered victims and did not want me to meet with the Sveinsons at all.

10. July 13 , 2007 - meeting with Taman family - 1 hour

11. July 16, , 2006 -meeting with both Taman and Sveinson family - 2 hrs (+)
