Re: Derek Harveymordenzenk

On review of the disclosure as I now have it in respect of the above noted matter, I note that I am not in possession of the following documents:

1. The report prepared by Cst. Chris Blanchard (Traffic Analyst of the RCMP Headingley Detachment);
2. The paramedic report;
3. The statement of the witness Cathy Beattie.

In addition, I do not know whether or not a warrant to seize the records of Brannigan's Restaurant for February 25, 2005 was ever obtained for the purpose of determining whether or not Mr. Zenk did use his credit card for purchases at this restaurant.

I am aware when WPS Officers conducted their investigation, the restaurant/bar staff indicated many of the transactions were conducted by way of cash purchase. Nonetheless, it would seem appropriate to determine with some degree of certainty whether or not any purchases can be attributed to Mr. Zenk by way of his credit card. It would seem the most efficient way to resolve this issue would be by the execution of a search warrant for that record on Brannigan's for the date in question, which may easily be identified through their computer system, and if successful we can then move forward to the next level of seizing the specific records of Mr. Zenk.
